Subject : Regarding the conduct of University examinations and declaration of exam results for the session 2019-20.

Reference : The Ministry of Higher Education, M. P. order no F-770/2020/38-3, Bhopal, Dated- 13-08-2020.

In view of the Corona (Covid-19) pandemic, considering the safety and health of the students, the state government has issued directives in context to the university examinations for the session 2019-20 following the guidelines issued by the University Grants Commission, New Delhi dated 29.04.2019 and 08-07-2020 and the Ministry of Human Resource Development Government of India, dated 08-07-2020.

The order issued on August 13, 2020 by the department of higher education, Government of Madhya Pradesh, is to be implemented on traditional courses as well as the courses of the Pharmacy Council of India (PCI) for the session 2019-20. The examinations of the final year students of Under Graduate and Post Graduate courses are to be held via open book exam system. It has been decided that the exam results for UG First year will be declared on the basis of marks obtained in internal assessment with present session. For UG Second year and PG Second Semester, exam result will be declared by adding 50% of the total marks obtained in the last year's examination and 50% of the total marks obtained in internal assessment in the present session.

In context to the Covid-19 and following the guidelines issued by the Ministry of Human Resource and Development, Government of India and University Grants Commission, New Delhi, the state government has decided that this arrangement of the conduct of examination and declaration of exam results for all the universities in the state shall be valid only for the session 2019-20. It shall not be considered as an example for the future years.


